## PROCEDURE FOR VACATION OF EASEMENTS OR RIGHTS-OF-WAY

Requests for Vacation of easements or rights-of-way may be made by any person affected by said easement or right-of-way. Petition for vacation must be signed by all property owners which have an interest in said easement or right-of-way. For example, a request for vacation of an alley must be signed by all person(s) adjacent to and/or deriving access from said alley. Vacation of an easement must be signed by all property owners over which the portion of the easement requested for vacation lies.

Any questions regarding an application for vacation may be directed to the Department of Community Development at 913-477-7500.

#### TO BE COMPLETED BY THE APPLICANT

- Complete Petition for Vacation. File original with the Department of Community Development. Petition to be accompanied by a check for \$200 made payable to the City of Lenexa.
- 2. Provide to the Department of Community Development, a legal description of the area requested to be vacated. The vacation requested should be the smallest portion of the property possible.
- 3. Provide to the Department of Community Development a copy of the plat or lot survey showing the existing easement and the area requested to be vacated.
