UNEMPLOYMENT BENEFITS

Actions at the state and federal level to relieve the financial impacts of the coronavirus outbreak have enhanced unemployment benefits, including waiving waiting requirements, expanding unemployment insurance to include more workers and increasing weekly benefits. **The Kansas Department of Labor** manages unemployment requests and questions.

UTILITIES

State orders have temporarily prohibited utility providers from canceling or suspending service as a result of non-payment due to COVID-19.

Many **local utility providers** are also implementing customer service changes, such as closing their lobbies, to limit exposure to the virus.

Your **trash provider** may be making changes to their curbside collection policies. Some trash companies are stopping any services that require

hands-on collection, such as yard waste and bulky item pickup.

DRIVER'S LICENSE RENEWALS AND REGISTRATIONS

Kansas Governor Laura Kelly signed an executive order extending deadlines for driver's license renewals and vehicle registrations. All renewals and registrations must be completed within 60 days of the expiration of the order.

EVICCTIONS AND FORECLOSURES

Evictions and foreclosures that are the result of nonpayment due to financial hardships directly or indirectly caused by COVID-19 are temporarily prohibited under an executive order signed by Governor Kelly.
